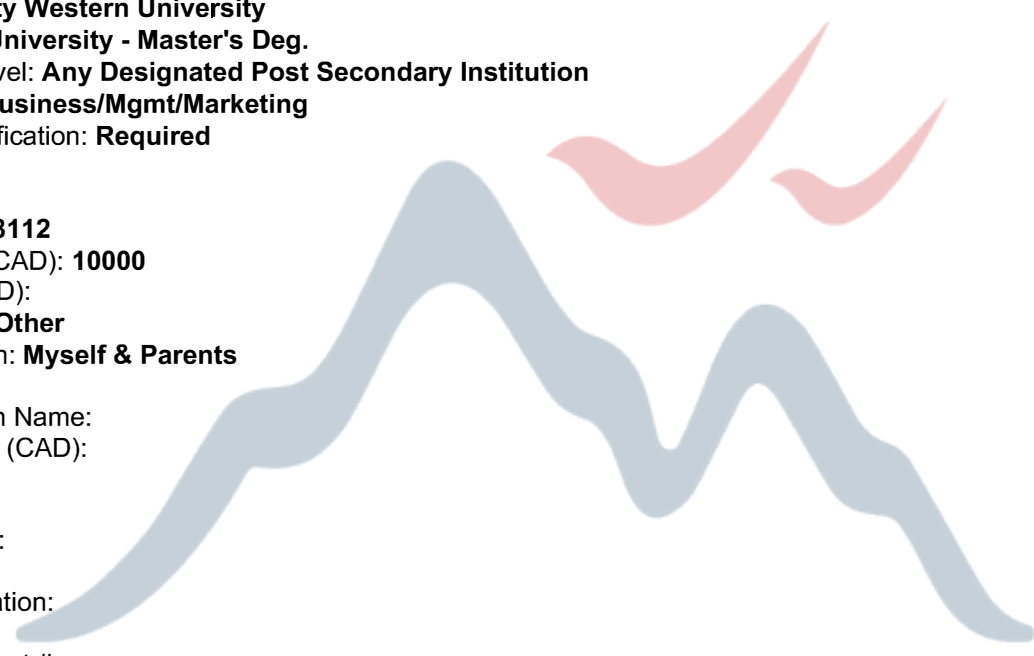

I have considered the following factors in my decision.

PA is a 26-year-old Iranian national. PA is applying for MBA, International Business at Trinity Western University. Previous university studies: Bachelor's in Mechanical Engineering. Currently working as a Marketing and Sales Assistant.

The applicant does not have significant family ties outside Canada. I note that PA is single, mobile and has no dependents.

The purpose of the visit itself does not appear to be reasonable since similar programs are available closer to the applicant's place of residence at a lower cost.

The applicant's previous studies were in an unrelated field to the proposed studies.

Based on the documentation on file to support the applicant's level of economic establishment and considering the purpose of the visit, I do not consider that the proposed studies in Canada is a reasonable or affordable expense.

Weighing the factors in this application, I am not satisfied that the applicant will depart Canada at the end of the period authorized for their stay.

For the reasons above, I have refused this application.

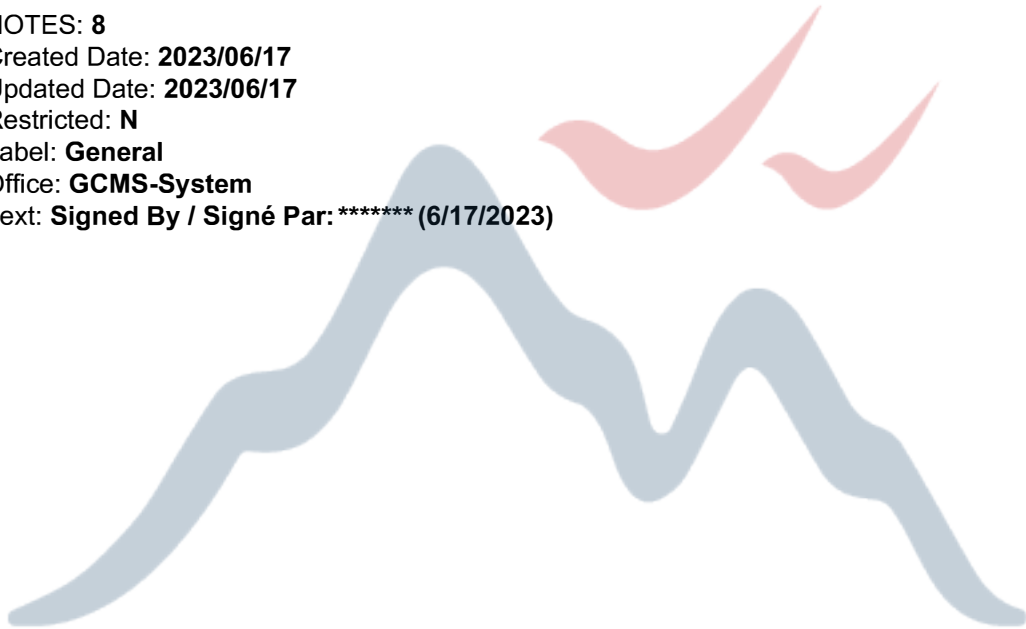
